### Methods and materials for containment and cleaning up

**Large spill** Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Dispose of via a licensed waste disposal contractor.

### Precautions for safe handling

### Appropriate engineering controls
